Firefighter/Paramedic

The Opportunity & Ideal Candidate:

The City of San Gabriel Fire Department is currently seeking experienced Firefighter/Paramedics. Under general supervision, Firefighter/Paramedics are a part of a fire suppression/rescue team that responds to emergency medical incidents, structure fires, wildland fires, vehicle accidents, hazardous materials, spills/releases, and additional types of routine and non-emergency calls for service.

Duties include but are not limited to fire prevention, completion of written reports and memoranda, public education, emergency/disaster preparedness, and station and apparatus maintenance, and other duties as assigned. Firefighter/Paramedics are also required to participate in emergency medical services continuing education, firefighting proficiency training, and in-house educational programs.

Minimum Qualifications:

Candidates must be at least 18 years of age and possess a high school diploma or GED equivalent. All candidates must be in good standing with a professional fire department or district, have a minimum of six (6) months experience as a San Gabriel Auxiliary Firefighter and serving as such at the time of employment or have a minimum of one year experience as a volunteer or paid auxiliary with a city, county or district within the state of California and serving as such at the time of employment; possess a certificate of completion from a California State Fire Marshal's Office accredited fire academy or a California State Fire Marshal Firefighter I certificate; and possess a valid California EMT-P License.

A valid Class C California Driver's License is also required by the time of appointment. After a candidate is appointed, conditions of continued employment include: Los Angeles County EMT-P accreditation within three months of appointment and continued accreditation to practice as an EMT-P in Los Angeles County.

Benefits:

- Participation in the CalPERS Retirement System: 2% @ 50 for "classic" CalPERS members and 2.7% @ 57 for new CalPERS members.
- A choice of multiple PPO and HMO medical plans (the City contracts with CalPERS for health insurance), two dental plans, and a vision plan.

Other Benefits:

- o Choice of enrollment in multiple Deferred Compensation (457) Programs.
- o Optional enrollment in Supplemental Insurance Programs.
- o City-paid life insurance (1x annual salary).
- o City-paid Employee Assistance Program (EAP) and Travel Assistance Program for employees and eligible family members.
- o Payment of retiree (and family) health insurance per established vesting schedule.
- o Bilingual pay of \$100 per month is available to employees who qualify and pass a proficiency examination in a second language such as Cantonese, Mandarin, Vietnamese, or Spanish.

Leaves:

- o 72 hours of sick leave per year
- o 144 hours of vacation per year (escalates with length of service)
- o 156 hours of holiday pay per year

Cash Outs:

- Sick Leave Buy Back Program allows the option to cash out up to 50% of unused sick leave accrued in the established 12-month period.
- Vacation Buy Back Program allows the option to cash out up to 40 hours of unused vacation per year.
