Ordinance Requirements:

The San Gabriel Municipal Code requires that at least one of the following conditions be met for approval.

1. The tree constitutes a **nuisance or hazard** by virtue of its condition, location, species, and/or proximity to existing structures, walkways or utilities.
2. The pruning or trimming of the tree is **deemed necessary** by a professional arborist to maintain or enhance the health or appearance of the tree.
3. The tree has not been reduced in height more than **one-fourth (25%) over a two-year period.**
4. The pruning, trimming or removal of the tree is necessary to prevent a substantial inconvenience or **financial hardship to the property owner.**

*The Community Development Department Director issues all tree removal/trimming permits. Decisions are based on the four (4) eligibility criteria listed above, as set forth in San Gabriel Municipal Code, Section 95.24. Tree Trimming and Removal Policy

The following table shows the recommended number of replacement trees based on the size of the trees that have been approved for removal. Size of replacement tree is to be determined by the City. **Palm trees and fruit trees will not be accepted as replacement trees.**

Size of tree trunk 4' above the ground	4"-10" Diameter	10"-25" Diameter	25" Diameter
Number of replacement trees required*	2	3	4

All permits are approved or denied within a week of the receipt of the completed application. Staff will evaluate status of trees at property address, following application submittal. A recommendation will be made by staff as to approval or denial of the permit. Once a recommendation is made, the application is submitted to the Community Development Department for a final decision. A copy of the signed permit is then mailed to the applicant and the original kept in file. Applicants must meet conditions recommended by the City within thirty (30) days of receiving their permit results. *Failure to comply may result in legal action.*
