B. PROFESSIONAL SERVICES AGREEMENT WITH RKA CONSULTING GROUP TO PROVIDE ENGINEERING SERVICES FOR STREET DESIGN AND SUPPORT

This is a request for approval of a professional services agreement with RKA Consulting Group for three fast-track street improvement projects which are scheduled to be designed and constructed prior to the end of the 2018 calendar year.

Recommended Action:

Staff recommends that the City Council:

- Approve the Professional Services Agreement with RKA Consulting Group; and
- 2. Authorize the City Manager to execute said Agreement and approve a purchase order in the amount of \$118,057.50.

C. MEMORANDUM OF AGREEMENT FOR RIO HONDO LOAD REDUCTION STRATEGY – DESIGN DEVELOPMENT PHASE FOR PREPARATION OF CONSTRUCTION PLANS

The execution of this Memorandum of Agreement regards the administration and cost sharing for the preparation of design plans of MS4 load reduction strategy projects for permittees that drain to the Rio Hondo Watershed of the Upper Los Angeles River Watershed. San Gabriel's share is not to exceed \$16,800.00. The cost to participate in the Rio Hondo Load Reduction Strategy MOA is funded in account 121-800-03-21-000.

Recommended Action:

Staff Recommends that the City Council:

- Approve the Memorandum of Agreement (MOA) between the County of Los Angeles, and the cities of Alhambra, Monterey Park, Pasadena, Rosemead, San Gabriel, San Marino, South Pasadena, Temple City and the San Gabriel Valley Council of Governments regarding the administration and cost sharing among the parties related to the Load Reduction Strategy projects for the Rio Hondo River and tributaries; and
- 2. Authorize the City Manager to sign the MOA.

D. BANNER REQUEST – ASIAN AMERICAN ECONOMIC DEVELOPMENT ENTERPRISES

The City has received a banner request from the Asian American Economic Development Enterprises (AAEDE). The AAEDE will be hosting a Free Career/Job Fair on Thursday, August 16, 2018 to serve the surrounding cities and the San Gabriel community. This event will take place at Almansor Court located at 700 S. Almansor Street, Alhambra, CA 91801. The AAEDE is requesting to have the banner hung at the intersection of Las Tunas Dr. and Mission Dr. from July 18, 2018 to August 16, 2018. That location has been verified and is available during these dates.

Recommended Action:

Staff recommends that the City Council grant the request, subject to compliance with Section 153.334(A) of the Municipal Code and the street banner conditions as listed on page 2 of the street banner application form.

6. NEW BUSINESS

A. APPROVAL OF RESOLUTION NO. 18-33, AMENDING THE SALARY SCHEDULE TO ADD THE DEPUTY FIRE MARSHAL CLASSIFICATION

On April 3, 2018, City Council passed Resolution No. 18-14, approving the new MOU language for the San Gabriel Firefighters' Association (FFA). In the new FFA MOU language, the Deputy Fire Marshal assignment was eliminated to

create a standalone, non-sworn Deputy Fire Marshal classification. Staff seeks approval from the City Council to amend the current salary schedule to add the Deputy Fire Marshal classification. Per CalPERS and California Code Regulations 570.5 and 571(b), the City Council is required to formally approve any amendments made to the salary schedule.

Recommended Action:

Staff recommends that the City Council approve Resolution No. 18-33, amending the salary schedule to add the Deputy Fire Marshal classification.

B. PROFESSIONAL SERVICES AGREEMENT WITH CIVITAS ADVISORS TO FORM A "TOURISM AND MARKETING IMPROVEMENT DISTRICT"

Promoting the City as a destination to visitors will help ensure occupancy rates remain high at the City's major hotels and, therefore, of interest to both the City of San Gabriel and the hotels. The formation of a tourism and marketing improvement district (TMID) will generate a new, stable source of funding for marketing and promotion efforts by charging the hotels an assessment fee for guest room rentals. Community Development circulated a Request for Proposal (RFP 18-07) seeking a consulting firm to create a TMID in San Gabriel. Staff seeks City Council approval to enter into a professional services agreement with Civitas Advisors.

Recommended Action:

Staff recommends that the City Council:

- 1. Execute the professional services agreement with Civitas Advisors to create tourism and marketing improvement district in the amount not to exceed \$44,500 with a 25% hold back.
- 2. Appoint a Council project liaison, should Council desire.
