C. SECOND READING AND ADOPTION OF ORDINANCE NO. 654 AMENDING TITLE XI, SECTION 110 THE SAN GABRIEL MUNICIPAL CODE- BUSINESS LICENSES

Adoption of the referenced Ordinance No. 654 amending Title XI, Section 110 of the San Gabriel Municipal Code will add a provision for exempting certain performers at City sponsored events and any Community Services recreation program individual instructors, coaches and/or referees from business license fees, add a provision for prorating business license fees for non-San Gabriel vendors at City sponsored events, and correct various business license fees to match the amount adopted with Ordinance No. 356-C.S. on July 16, 1991. No business license taxes are being added or increased.

Recommended Action:

Staff recommends that the City Council waive full reading, read by title only, and adopt at the 2nd reading, Ordinance No. 654 amending Title XI, Section 110 of the San Gabriel Municipal Code, pertaining to Business License Taxes.

D. CALIFORNIA FOR ALL- COMMUNITY EMERGENCY RESPONSE TEAM (CERT) AND LISTOS CAPACITY BUILDING GRANT

The San Gabriel Fire Department has been awarded grant funds in the amount of \$20,000 from the 2019 California For All Emergency Preparedness Campaign. This is designed to help Community Emergency Response Team (CERT) and LISTOS (Spanish for Ready) programs. The San Gabriel Fire Department will apply these funds towards engaging San Gabriel community members in

emergency and disaster preparedness. The award of the grant will require a budget amendment for receipt and use of the grant funds.

Recommended Action:

Staff recommends that the City Council adopt Resolution No. 19-46, increasing the revenue estimates and appropriations (transfer out) in the Other Grants Fund (186) by \$20,000 to receipt and transfer the funds and increasing the revenue estimate (transfer in) and appropriations by \$20,000 in Capital/Special Project Funds (account number 124-761-57-96-341). Staff further recommends that the City Council authorize the Interim Fire Chief to accept the California For All CERT and LISTOS Capacity Building Grant and purchase the items within the confines of the City's purchasing policy.

E. SECOND READING AND ADOPTION OF ORDINANCE NO. 653 – ZONE TEXT AMENDMENT TO UPDATE THE SAN GABRIEL MUNICIPAL CODE RELATING TO ACCESSORY DWELLING UNITS (PLANNING CASE NO. ZTA19-001)

At the September 17, 2019 City Council meeting, Ordinance No. 653 was introduced by a 5-0 vote. Adoption of this Ordinance would delete references to previous accessory unit options, provide clarification to Accessory Dwelling Units (ADU) development, and add a requirement for a covenant to be recorded with all future ADU applications.

Recommended Action:

Staff recommends that the City Council:

1. Waive the reading in full; and
2. Adopt Ordinance No. 653, an Ordinance of the City Council of the City of San Gabriel Amending Chapter 153 (Zoning Code) of the San Gabriel Municipal Code Relating to the Development of Accessory Dwelling Units (ADUS).

F. RESOLUTION NO. 19-40 FOR TEMPORARY STREET CLOSURE REQUEST FOR BLOCK PARTY - 371 N. DUANE AVENUE

The Public Works Department received a request from Carla J. Seifi for a temporary street closure. The purpose of this event is to hold a block party on Saturday, October 19, 2019, from 4:00 p.m. to 10:00 p.m. in the 300 block of N. Duane Avenue. The closure will take place between Sycamore Drive and Adelyn Drive only. Resolution No. 19-40 details the location, date and times for the closure, as well the conditions that must be followed by the applicant. The

Public Works, Fire, and Police Departments have reviewed and approved the request.

Recommended Action:

Staff recommends that the City Council adopt Resolution No. 19-40 authorizing closure of the 300 block of North Duane Avenue between Sycamore Drive and Adelyn Drive from 4:00 p.m. to 10:00 p.m. on Saturday, October 19, 2019.

G. RESOLUTION NO. 19-44 FOR TEMPORARY STREET CLOSURE AT 851 E. GRAND AVENUE BETWEEN GLADYS AND THE RUBIO WASH ON OCTOBER 5, 2019

The Public Works Department received a request from the San Gabriel Valley Humane Society for a temporary street closure for a 95th anniversary celebration on Saturday, October 5, 2019 from 7:30 a.m. to 6:00 p.m. on Grand Avenue between Charlotte Avenue and the Rubio Wash. The closure will take place at 851 Grand Avenue between Charlotte Avenue and the Rubio Wash. Resolution No. 19-44 details the location, date and times for the closure, as well the conditions that must be followed by the applicant. The Public Works, Fire, and Police Departments have reviewed and approved the request.

Recommended Action:

Staff recommends that the City Council adopt Resolution 19-44 authorizing closure of Grand Avenue between Charlotte Avenue and the Rubio Wash from 7:30 a.m. to 6:00 p.m. on Saturday, October 5, 2019.

H. LS-1 OPTION E AGREEMENT WITH SOUTHERN CALIFORNIA EDISON (SCE) TO REPLACE HIGH PRESSURE SODIUM VAPOR STREET LIGHTS WITH LIGHT-EMITTING DIODE (LED) STREET LIGHTS CITYWIDE

On June 1, 2015, the LS-1 Option E tariff became available to cities for street light (LED) retrofits. This program allows Southern California Edison (SCE) to replace High Pressure Sodium Vapor (HPSV) street lights with more efficient LED street lights with no out-of-pocket capital cost to cities. Instead, initial capital costs will be amortized through energy cost savings over a 20-year period. SCE owns and maintains 460 street lights throughout the City of San Gabriel (City) along residential and arterial streets. The City pays SCE a monthly facility fee for each pole which includes the cost of electricity and required maintenance. The annual City's budget for the subject street lighting is approximately \$66,493. These types of street lights are referred to as LS-1 lights and fall under SCE's LS-1 cost tariff.

Recommended Action:

Staff recommends that the City Council:

1. Approve an LS-1 Option E agreement with SCE to replace High Pressure Sodium Vapor (HPSV) street lights with Light Emitting Diode (LED) street lights; and
2. Authorize the City Manager or his designee to execute the Southern California Edison Company Schedule LS-1 Option E, Energy Efficiency-Light Emitting Diode Fixture Replacement Rate Agreement.

6. NEW BUSINESS

A. MEMORANDUM OF AGREEMENT (MOA) WITH SAN GABRIEL VALLEY COUNCIL OF GOVERNMENTS

During the September 17, 2019 City Council meeting, staff presented a wildlife management update which included several alternatives for the City Council to consider, including a Memorandum of Agreement (MOA) with the San Gabriel Valley Council of Governments (SGVCOG). Should City Council approve the MOA, it will provide the City of San Gabriel with services related to the Regional Coyote Management Network (RCMF) for a cost of \$20,000 for the next two years.

Recommended Action:

City Council to approve the Memorandum of Agreement and authorize \$10,000 to be transferred to from the General Fund contingency account to pay for the implementation of the agreement.

B. ROLES AND RESPONSIBILITIES OF THE HISTORIC PRESERVATION AND CULTURAL RESOURCE COMMISSION

On August 15, 2017, the City Council adopted Ordinance No. 636 to amend provisions of the San Gabriel Municipal Code (SGMC) Chapter 153 (Zoning Code) relating to historic preservation and cultural resources (Attachment A). Adoption of the Ordinance capped a multi-year effort to modernize and strengthen the SGMC in an effort to protect historic resources in the city, preserve San Gabriel's heritage for future generations, promote public

education, participation and appreciation of historic preservation and preserve diverse and significant architectural styles as well as historic preservation objectives. The Ordinance was praised and/or recognized by the San Gabriel Historical Association, Pasadena Heritage, American Planning Association – Los Angeles, Los Angeles Conservancy, and California Preservation Foundation.

Recommended Action:

Staff recommends that the City Council discuss the role of the Commission and provide direction to staff on whether any changes need to be made. If this direction would result in the need to amend the existing Historic Preservation and Cultural Resource Ordinance, direction to initiate a ZTA is required.

C. PRESENTATION ON THE PUBLIC WORKS CITYWIDE MAINTENANCE PROGRAM

The City of San Gabriel (City) owns and maintains the majority of infrastructure within the public right-of-way. Public Works staff is responsible for constructing, maintaining and preserving City-owned infrastructure including streets, sidewalks, the sanitary sewer system, the stormwater system, traffic signals and signs, street lights, pavement markings, public landscape and trees, parks, and City facilities. Staff desires to present the City Council with an update on the new Public Works proactive citywide infrastructure maintenance program.

Recommended Action:

Staff recommends that the City Council receive and file the Update.
